With the regulation (EC) No. 1907/2006 of the European Parliament and the Council from December 18, 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH), a further step was conducted in order to ensure maximal security in the production and use of chemicals.


In response to your inquiry about **MULTI-PLASTICS EXTRUSIONS'** film/sheet products and their status with respect to REACH requirements, we have prepared a statement certifying our compliance with the provisions of this regulation pertaining specifically to the importation of our products into the EU. We at **MULTI-PLASTICS EXTRUSIONS** fully understand our responsibility in the entire value chain and fulfill all obligations which result from REACH.

All products manufactured and exported to the EU by **MULTI-PLASTICS EXTRUSIONS, INC.** are in compliance with REACH. Our products are articles in terms of REACH definitions and are therefore exempt from registration. Our products do not contain substances which are released under normal or reasonably foreseeable conditions of use (REACH Article 7 (1)). EU-Importers of our products are therefore relieved from any registration or notification obligations.

As a downstream user of substances and formulations it is of utmost importance for us that all substances which we are using are sustainable raw materials, have a low hazard potential and will be available on the market in the future. Therefore, we have contacted our raw material suppliers to confirm the supply and the sustainability of the raw materials we source from them. Due to the received feedback we can confirm, that all substances which are used in our products, have been pre-registered and are being registered in the EU for their intended use in such articles.

This verification at our suppliers includes Substances of Very High Concern (SVHC) as defined in Article 57 of REACH. However, we do not specifically test for each of those substances as they are not intentionally added to our raw materials and are not expected to be present at any levels above the threshold limits identified in REACH based on our detailed knowledge of all of the raw materials used in our film and sheet products.
